## ONLINE PRIVACY STATEMENT

1. We at SHARP will provide you with our various products and/or services, and in order for us to do so, we kindly request that you provide us with your personal information such as your name, identification number, address, and telephone number. We may also keep records relating to your access of our web server.
